

WATER ACCOUNT QUERIES - APRIL 2023

The HOA has received a number of queries from residents regarding the sliding scale tariffs on their April water accounts and would like to allay any concerns that there is an error in the billing system.

The key to understanding any water invoice issued by PVHOA is to look at the billing period which indicates the number of days of consumption included in the invoice, as highlighted in the following example:

Water February 2023 Usage Water meter number: C-BRM9999 Reading date previous month 2023/01/27 Reading date current month 2023/02/24

Billing period: 28 days

Reading previous month (kl): 1811.38 Reading current month (kl): 1910.06 Water usage current month (kl): 98.7

The billing period is not constant, as it is determined by the number of days in the month and the date of each month's meter reading, which can vary by a few days. Typically, the billing period is 30 or 31 days, but it can sometimes be a few days more or a few days less.

The billing period has a direct impact on water accounts as a longer period between meter readings will result in higher consumption being charged at higher rates. To mitigate this, PVHOA (like other estates) applies a Drakenstein-approved "normalisation adjustment" to water invoices when the billing period is less than 30 days or more than 31 days. The adjustment essentially pro-rates the sliding scale band limits according to the number of days being billed. The effect is to smooth out residents' accounts on a month-to-month basis. This benefits residents by reducing the impact of the sliding scale tariff in the event of longer billing periods. For shorter periods, invoice values will be a bit higher than expected, but for longer periods they will be significantly lower than expected, resulting in a lower overall cost to the resident over a year.

The following table indicates the adjusted scale limits, according to the number of days in the billing period:

Please note that water invoices are prepared and issued by the HOA (not by Voltano) and all account payments are made to the HOA. Voltano simply provides the meter readings to the HOA and has no role in billing or collecting payments. Apart from the monthly service fee paid by homeowners (currently R42.60 plus VAT), Voltano receives no fees or commissions in respect of water consumption on the Estate.



The operation of drones anywhere on the Estate, without the consent of the HOA, is strictly prohibited in accordance with Estate Rule 8.

This rule exists for security reasons, as well as to protect residents' privacy, limit disturbances, and generally enhance the residential ambience and lifestyle within the Estate.

HOA consent is usually only granted for specific marketing or security purposes, and for special events.

Residents who might be affected will be notified in advance whenever such approval is given.

DOGS NOT ALLOWED ON THE GOLF COURSE

Most residential communities have strict rules in place concerning dogs, and Pearl Valley is no exception. These rules are intended to maintain a harmonious and safe environment for all residents. However, despite numerous reminders, some residents still choose not to comply, particularly when it comes to walking and running their dogs on the golf course.

According to Rule 12.4, dogs must be kept on a leash at all times when in public areas. This measure is to ensure that dogs remain under control and prevent any potential incidents or conflicts.

Moreover, Rule 12.5 specifically states that dogs are strictly prohibited on the golf course. This rule applies 24/7 (i.e., not only during playing hours) and is critically important to preserving the quality and integrity of the golf course and the playing experience for members and visitors alike.

The HOA appeals to all residents to respect and comply with these rules, in the best interests of the entire Estate community. Please note that the Estate Rules Transgression Chart provides for a fine of R1,000 for a first offence of dogs roaming/walking without a leash.
